

# Delegate Meeting Minutes DRAFT

## Metropolitan Washington Council, AFL-CIO

Called to order by President Jos Williams at 6:43p.

President Williams swore in new delegates Marry Battle (Cement Masons 891) and Katrina Dizon (OPEIU 2).

**Minutes**: November minutes were received.

**Financial Report**: Moved, seconded and approved to receive the November financial report.

#### Executive Board Actions/ Recommendations:

Delegates unanimously approved the following recommendations by the Executive Board:

- \$100 recommended for the 21st annual Covenant House Christmas Party held by Delegate Eleanor Holmes Norton on December 21.

- \$100 recommended for the ANC 4D Holiday Gift Drive, to be distributed via the Community Services Agency.

- Motion that the Council support PG and Montgomery County public sector locals, all of whom are now in negotiations with their County administrations.

- Motion to raise the Evening with Labor ticket cost to \$150 – the first increase in many years – and also to increase program ad costs and seek additional sponsors.

- Motion that the Council go on record as opposing the

Caffritz project, which includes the proposed College Park Whole Foods.

Occupy DC update: DC now probably only major city where occupiers haven't been removed; resources running low and help needed. Watch Union City for updates on current needs and how to help. This movement is raising issues about wealth disparities and jobs that have been the focus of the labor movement for years and deserves our strong support. Introduced new Assistant Mobilizer Julia Kann, the Council's liaison with

Occupy DC, who introduced a delegation of occupiers from McPherson Square's labor delegation. The delegation included a range of occupiers, from a local Iron Worker and Teamster staffer to as far away as New Mexico and Alaska. They said that the struggles by the Occupy and labor movements "are the same struggles" and that "We're all fighting for rights for American workers, and against corporate greed." They shared their "mission statement," needs list and outlined the availability of the new Labor Tent donated by the Metro Council, but which needs staffing. With the onset of winter. they stressed that they face "serious challenges" and appreciate any and all support. They're looking to the future and following Noam Chomsky's dictum to "Build, Educate and Strike Later." The Occupy DC Labor Committee meets every Sunday at 2p at McPherson Square, but may well move inside to the Metro Council offices because of the weather.

Following the suggestion of Rick Ehrmann, Newspaper Guild 32035 it was moved, seconded and unanimously approved that the Council notify the federal government, DC Mayor and City Council that the Metro Council urges them not to dislodge the Occupy DC encampments and to

uphold their rights to continue their peaceful occupations. Further, in the event that an effort is made to clear the encampments, the Metro Council will issue an alert so that the metro area labor community can turn out in solidarity with Occupy DC.
