She thanked SMART Local 100 for including CSA in their national union Business Agent's conference which netted donations to CSA of \$96,000.

Jackie Jeter, ATU 689, reported on the local's recent win at First Transit: they had filed a group grievance against the private contractor over its violation of DC's paid sick days law. First Transit agreed to bring its policies into compliance with the law, retract disciplinary points from current employees, and re-hire workers who were unjustly fired. She also reported on ATU recently setting up an encampment dubbed ence which will be held locally the weekend of October 2-5. "WMATAville" in front of a Hyattsville garage owned by

Transdev, a private subcontractor for MetroAccess, to help ratchet up the pressure for a settlement of a new contract for the 440 Transdev workers, who belong to ATU Local 1764.

Jean Dearden, Bonnie Ladin Union Skills program coordinator, reported on upcoming classes being offered by the program.

COPE Report

DC Legislative/Political Coordinator David Dzidzienyo reported on recent activities and meetings with the DC Attorney General's office and introductions of new legislation at the DC City Council including increasing the maximum weekly benefit amount for unemployment compensation.
