EXECUTIVE BOARD MINUTES: April 18, 2016

President's Report Jackie Jeter reported:

- 1. Strategic Plan Update- the Board to review the existing strategic plan and see what adjustments need to be made in the plan including clarifying committees and committee members. Plans to get the Committees active to begin the process of addressing those areas. Also, looking over the Council as a whole to see what improvements need to be made.
- 2. Evening with Labor- the President appointed a committee to review the event and make some recommendations to the Board by the next meeting, with a look at cost, location, music arrangements, the program, and the dates for 2017. Committee members are Doris Reed (ASASP), Dena Briscoe (APWU 130), Jim Griffin (IBEW 1900), Dyana Forester (UFCW 400 for Mark Federici). Kathleen McKirchy who has coordinated the dinner for many years, will staff the committee.
- 3. A resolution promoted by SMART Local 100 was reviewed in support of the Federal Railroad Administration crew size rule (see below). After discussion, it was moved, seconded and approved.

Resolution in support of Federal Railroad Administration crew size rule

WHEREAS, the safe operation of freight and passenger trains is vital to commerce; and the Metropolitan Washington Council, AFL-CIO supports efforts to keep train operations safe in the Metropolitan Washington, DC area; and WHEREAS, the Federal Railroad Administration (FRA) has published a notice of proposed rulemaking (NPRM) regarding adequate staffing on trains, a factor we believe is vital to ensuring safe train operations; and

WHEREAS, polling across America from North Dakota to Alabama shows overwhelming bi-partisan support of two-person crews, with 83 to 87 percent of those polled in favor of mandating that trains be operated by a crew of at least two qualified individuals; and

WHEREAS, national studies show that a minimum of two on-board crew members are vital to operate a train safely and minimize the likelihood of train-related accidents; and WHEREAS, virtually all trains in North America are already operated by crews of at least two individuals, making the economic impact of this proposed rule minimal; and

WHEREAS, the FRA agrees that, while advancements in automated technology such as Positive Train Control

(PTC) systems improve railroad safety, they are not a substitute for a train's on-board crew members,

NOW, THEREFORE be it resolved, that the Metropolitan Washington Council, AFL-CIO does hereby support the FRA's proposed ruling, requiring that trains operated in America be operated by no less than a two-person crew; and

BE IT FURTHER RESOLVED that this resolution be filed with the United States Department of Transportation in the form of comments in support of the proposed federal rule. Dated this 18th day of April, 2016.
