Metropolitan Washington Council Executive Board Meeting May 18, 2020 (Via Zoom)

- Roll call of Officers and Executive Members
- · Call to order
- Juanita Sanchez (AFL–CIO) reviewed the Code of Conduct mandated by the AFL CIO concerning participants' behavior during meetings. Chris Garlock will be the contact for the Council and Gina Walton will be the contact for the election committee.
- Motion made by Jim Griffin (IBEW 1900) to accept April Executive Board minutes seconded by George Farenthold (OPEIU 277).
- Financial report was given by Treasurer Eric Bunn (AFGE), who stated that Labor Key (the new per capita billing system) is not coordinating with Quick Books. Example the invoices are not correct. Mr. Bunn recommended not to approve the Financial report for May until it can be corrected. Motion was made by George Farenthold (OPEIU 277) and seconded by Dan Fields (SEIU 722) to table. It was also reported that Jo Combs and Eric Bunn will be taking training on Labor Key as well as the MWC's auditor.
- Election Committee member Larry Greenhill resigned from the Committee and Chuck Clay (IATSE 22) was appointed. Chuck Clay accepted the position.
- Acting President Andrew Washington discussed the fact that unemployment payments are behind. CSA can help members in need during the pandemic. He also reported no major issues for the Metro Council. Former DC Councilwoman La Ruby May was invited to discuss issues at a future meeting. Reopening DC committee recommendations. Chuck Clay was selected to the labor focus group. Motion made by Chuck Clay (IATSE 22) to accept the President's report, seconded by George Farenthold (OPEIU 277). Robin Burns (DCNA) abstained.
- Jaime Contreras (SEIU 32BJ) discussed Metro Council staff contract negotiations with the Guild about health care. Andrew Washington discussed the health care exchange providers using accurate quotes. Eric Bunn discussed the health care extension for staff. Contract negotiations date back to expiration of the previous contract at the end of 2018. The Guild has also raised the issues of David Stephen' 90-day pay increase after his probationary period.
- Discussion about the cost of Election Buddy going the allotted time for the election.
 Candidates will have 3 minutes to speak to the Delegates. Eric Bunn requested a print-out of the locals in arrears.
- June 10th Swearing-in of new Delegates to Metro Council. No one's voting strength will be reduced. Per capita payments will reflect April 2019 to April 2020, per the constitution. Wanda Shelton-Martin discussed that the wrong name was used for NUHHCE 1199 and the per capita was incorrect. Jim Griffin said that IBEW 1900's per capita payments were incorrect as well and asked if it would affect their voting strength. The original cost of Election Buddy was \$1,398.00 but to cover additional prep work the board increased the

cost allowance to \$2,500.00. Motion made by Andrew Washington to approve the increase, seconded and approved by the committee as a whole.

Tonight's delegate meeting and election will have its logistical challenges, just based on the number of delegates we are expecting to participate (over 200 have already registered). As in last month's delegates meeting, all candidates will have the opportunity to address the delegates one last time prior to the actual voting tonight. Each candidate will have up to 3 minutes to address the delegates; the time limit will be strictly enforced.

I would also like to express my gratitude and appreciation to the Election Committee -- Chuck Clay, Amy Millar, Kathleen Moors and Gina Walton -- as well as MWC staffer Chris Garlock, for their dedication, commitment and incredibly hard work over what turned out to be a much longer period of time and much more complex process than anyone anticipated. It has truly been an honor to serve with them on this committee.

Finally, on behalf of the Election Committee, we wish all the candidates, delegates and affiliates the best of luck and solidarity as we all work together to build a stronger labor movement for all working people throughout our community.



As of June 9, 2020, \$59,529 has been allocated for rent, utility, car loan, medical bills and food. \$24,275 has been allocated for food, comprising almost half of the requests for emergency assistance. Three hundred and seventy-eight workers (378) have been served.



The executive director is working with UNITEHERE Locals 23 and 25, SEIU Local 32 BJ, AFSCME Locals 709 and 1207 and has reached out to other locals impacted by COVID-19 layoffs to get referrals for members laid off.

CSA helps "lift a big burden" off worker's shoulders

AFSCME Local 1207 member Jamie Brown (left) is one of 80 cleaners laid off in early May when the Washington Convention Center was reconfigured into a COVID-19 field hospital. The 32year-old has three children, aged 2, 8 and 14. "I have been stressing in many ways trying to figure out how to come up with the money during this pandemic," Jamie told Union City. The Metro Council's Community Services Agency and her union helped her pay the rent, and she says "I am thankful for the help. It lifted a big burden off of my shoulders." Through its Emergency Assistance Fund, CSA has been able to help over 100 local workers with rent, utility, food and other basic necessities. "Broad-based support from the Metro Washington labor community, individual donors, the Greater Washington Community Foundation and the United Way National Capital Area made the funding possible to keep Jamie and her family in their home," said CSA Executive Director Sonte DuCote. "Stories like Jamie's show the real impact of these generous contributions, keeping our communities strong throughout the COVID-19 crisis," she added.

Fundraising

Unfortunately, there is a 99.9 percent chance that Labor Night at the Nats scheduled for July 24 will not happen due to COVID-19 rules regarding public gatherings.

The CSA Golf Tournament scheduled for September 21st is canceled. According to the Enterprise Golf Course Manager, Allen Loreg, tournaments are canceled for this golf season due to COVID-19.

The executive director will work with the pro bono group COMPASS to identify potential grant and program opportunities for CSA.

BUILDING FUTURES PRE-APPRENTICESHIP PROGRAM

During the past month, CSA's Client Services Coordinator, Sylvia Casaro-Dietert and her team completed virtual recruitment activities in preparation for the Building Futures Construction Pre-

Apprenticeship Program summer cohorts. Building Futures Virtual Classroom will be launched on June 15 as a hybrid model to be complemented with in-person training later in July or when gatherings of more than 10 individuals becomes available in DC, which is where the training site is located.

Building Futures program activities and outcomes were as follows:

- Screening and enrollment of 50 DC residents to participate in the upcoming summer cohorts funded by UPO CSBG and DOES respectively. Activities: Weekly virtual recruitment events for government and community partners, daily processing of candidates' intakes and engagement activities to ensure process quality and candidate retention.
- Adaptation of AFL-CIO-approved MC3 Curriculum and BF
 Applications for distance learning. Activities: Content formatting, creation/ compilation of self-learning projects and daily student assignments by module.
- Google Classroom and Zoom. Activities: Research, identification and set-up of low-cost, accessible and reliable digital platforms for Building Futures Virtual Classroom.
- Ready-to-go Instructors. Activities: Coordination of BF Instructors' regarding online instruction and schedule.





- Client engagement and retention. Activities: Follow-up and support of active and newly hired graduates.
- Accountability. Activities: Preparation and submissions of monthly/ quarterly reports; regular check-ins with contracts and grant officers to stay updated and maintain open lines of communication during the pandemic.
- •Marketing of Union Registered Apprenticeship. Activities: Regular check-ins with the building and construction trades union and their joint apprenticeship training committees to promote BF pre-apprenticeship, identify trade opportunities for women, veterans and minority graduates from our program, and include them as guest speakers to present their trade and registered apprenticeship programs in BF Virtual Classroom.
- Staying-in-the-know: Participation in DC City Council's Labor and Workforce Development Budget Oversight Committee.

CLAIMANT ADVOCACY PROGRAM

Tonya Love, Program Director; Lolita Martin, Attorney

Overall objective: Advised and represented claimants before the Office of Administrative Hearings. Discussed existing issues with DOES regarding regular UI, PUA, PUEC and FPUC. Finally, the most recent and urgent objective was/is to protect and preserve the existing language of the legislation that mandates funding for Claimant Advocacy Program, (CAP), under the current terms and conditions set forth in the requisite provision of the Act.

- 1. Invoiced for the month of May for a total of \$50,625.00.
- Represented and/or assisted hundreds of union and non-union members at unemployment compensation hearings, mediations sessions, initial claims, re-opening claims, and status updates. CAP further assisted claimants in accessing the unemployment system by not only initialing multiple calls, emails and texts to POCs at DOES but following up until each claimant's issue was resolved.
- 3. Took part in multiple conference calls with legal service providers and CM Silverman's staff regarding a proposed amendment intended to be included in the BSA and one that would have modified the existing CAP legislation. MWC, inclusive of the Program Director of CAP, Tonya Love, met with the CM's staff in order to gain a full understanding of the intent and effect of the proposed amendment. Following the meeting, all provisions that MWC perceived as having a negative impact on CAP were removed. Furthermore, over the course of subsequent conversations with Silverman's office, this amendment was further revised, still leaving intact CAP's funding and shifting focus to DOES modernization initiatives. CM Silverman and legal service providers will continue to work together to try to resolve issues that became blatantly apparent following the increased number of unemployment claims as a result of COVID19.
- Began discussions with DOES regarding COVID19 and how the transition to fully reopening DC could impact employees (currently claiming UI) that are concerned about returning to work.
- 5. Monthly DOES conference call with recommendations for procedural changes and expediting decisions/payment of benefits.

UNION CITIES

Chris Garlock, Coordinator

As I have since the beginning of the COVID-19 emergency shutdown three months ago on March 13, I have continued to work closely with Acting President Washington and the MWC staff to coordinate the remote operation of the Metro Washington Council and ensure continuity of the Metro Council's ability to carry out our responsibilities to our affiliates and the local labor movement.

In addition to my usual day-to-day duties, a major focus of my work over



the last month has been supporting the Election Committee's work preparing for the June 15 election of a new president and two board members. That has involved numerous meetings with the committee as well as with the staff of both ElectionBuddy and LaborKey. It's also involved extensive and detailed efforts to conduct outreach to MWC affiliates, leaders and delegates to update their information and membership. With nearly 200 affiliated locals and



over 400 delegates, this has been a massive undertaking under obviously unusual circumstances.

Another major component of my work continues to be maintenance and support for the MWC professional Zoom account, facilitating remote meetings for MWC staff, the Board, Election Committee, the LaborFest virtual screenings and COPE Town Halls.

Several mobilization efforts were undertaken over the last month, one

around the Workers First Caravan, originally scheduled for June 3 and now set for this Wednesday, June 17, the other around helping coordinate labor response/involvement with the ongoing Black Lives Matters protests. Work on both continues.

Here are highlights of my other work:

Union City, Union City Radio, MWC social media

Produced, published and distributed latest local labor news on the MWC's Union City daily, Union City Radio (WPFW 89.3FM) and Facebook/Twitter feeds, including extensive coverage of the COVID-19 pandemic and the efforts of DC-area unions and workers.

Union City has continued to appear every weekday since March 16; Union City Radio (WPFW 89.3FM) continues to run 7 days a week (formerly was on weekdays only); Your Rights At Work has broadcast every Thursday as usual.

I have continued working with all MWC staff to keep the labor community informed about news and resources on the local response to the pandemic, including keeping our website and social media – including Twitter and Facebook -- up-to-date, with the website – including the COPE, CAP and CSA pages – updated as necessary.

MWC meetings: Coordinated with AP Washington and the Board to hold the May Board meeting on May 18 and the delegate meeting on May 19, including preparing reports, notifying affiliates/delegates, etc. Both meetings were well-attended and the tech issues from previous meetings were resolved.

MWC check log-in: Opened, sorted, logged in MWC mail and checks. **Database updates:** Updated MWC and LaborKey databases as necessary.
