### Metropolitan Washington Council Delegate Meeting May 19, 2020 (Via Zoom)

Roll Call of Delegates

Swearing - in of New Delegates

Meeting called to order

Motion made by Murphy and second by George Farenthold to accept April Delegates report

Treasurers Financial report Eric Bunn as follows:

Transitioning from Labor Key to Quick Books the programs are not responding to each other. Request not to accept April Financial report. Motion Mike Spiller second by Chuck Clay to accept the Report.

#### President's Report

Mr. Washington reported on the reopening of Washington DC and also he is a member the committee. The chair is La Ruby May, former DC City Councilwoman. Discussed the testing of only Federal and District Employees for COVID 19. Mr. Washington wants testing for the public as well. Maryland reported 900 COVID-19 cases in one day. Half of Federal District Employees live in Prince George's County Maryland.

Mayor Bowser is proposing a 4-year freeze on raises for city workers. Some Employees can telework from home public and private Workers. Every state has to assess their budgets to make cuts.

The second Stimulus package is dead on arrival to the US Senate.

Liz Davis asked to address the freeze with DC Mayor Bowser and the City Council. She further stated that three unions would be affected by the freeze. Survey Mayor City workers budget proposal. Eric Bunn called public sector unions to discuss DC Mayor budget issues. D. Hall stated that 1199 would like to be a part of the conversation. Mr. Bunn discussed the small unions and non profits that would be affected by the freeze and that there a lot of small unions that need to be organizes to join the AFL – CIO. Eric Bunn stated that the mayor's budget will be balanced on the backs of labor and increased monies in other places. O. Banks asked if the freeze breaks the current negotiated contracts and will lose jobs. Union members have applied for unemployment and have not received a check.

Larry Greenhill resigned from the Election Committee and AP Washington appointed Chuck Clay to replace him on the Election committee (approved by the Board). Motion made and seconded to accept the President's report.

Election Buddy has been contracted for up to \$2,500.00 for additional time for the Delegates Meeting and Election.

Election Committee Chair David Fernandez-Barrial reported that election will be held at the June 15<sup>th</sup> regular meeting by Zoom; candidates will get 3 minutes each to speak before the election.

La Ruby May – former DC City Councilwoman -- and partner Will Lightfoot plan to introduce a fair workmen's Comp Law that will benefits all workers, called Public Workers Equality Act. Motion by George Farenthold and seconded by George Hogan to support the legislation.

Ann Hoffman asked for more transparency by including the Delegates in Executive Board Meeting.

#### Election

Eric Bunn requested that Candidates have 5 minutes to speak before the Delegates. It was agreed to extend the time as requested.

Introduction of the Election Committee: Amy Millar, Kathleen Moor, Gina Walton and Chuck Clay.

Candidates name and positions they seeking:

Executive Board: Greg Bowen, George Hogan, Mike Spiller.

President: Eric Bunn, Dyana Forester

Mr. Washington stated that, as the request of the MWC, President Trumka approved the use of ElectionBuddy as the program to use to conduct the MWC Election, which is set for June 15, 6:30 pm. Dan Fields asked about the date and time of the swearing-in of new delegates: 1 PM June 10<sup>th</sup>

Ann Hoffman asked about weighted votes or one person, one vote. It was explained that a motion on whether to vote by weighted vote or not will be made on June 15 and must be approved by 30% of the delegates present, per the constitution.

#### Affiliate reports

Dena Briscoe, APWU president: issues ongoing with Trump trying to privatize the Postal Service.

Federal cuts to Medicare, Medicaid and Social Security proposed by the Trump Administration.

Chuck Clay, IATSE 22, organized RC Signature Theatres in Arlington VA.

Delegate Rick Ehrmann of the Washington-Baltimore News Guild moved that the Metropolitan Washington Council conclude the MWC – Guild contract covering MWC's staff, including all TA'd items and maintaining the status quo regarding health benefits and that MWC staff member David Stephens be retroactively paid his post-probationary pay increase. Delegate Ann Hoffman seconded Ehrmann's motion. Acting President Andrew Washington ruled the

motion out of order because negotiations with the Guild were not over. He assured the delegates that the contract matter would be settled before his term ended and that the issues regarding staffer David Stevens' post-probation increase would be resolved. Dan Fields asked about the CAP Program salary for the two employees pay increase. Motion made to table conversation about contract negotiations.

#### Affiliates report

E. Falcon, Jobs with Justice, discussed Mayor Bowser's budget for Washington DC. Having a virtual meeting to discuss the upcoming Budget Freeze.

Community Service Agency raised \$150,000 and received two grants, with monies to be used by June 30<sup>th</sup> to help members with their utilities, groceries etc.

#### **Building Futures**

Sylvia is recruiting members for job training. Motion made by George Hogan, seconded by George Farenthold to accept affiliates reports.

Motion to Adjourn, made by George Farenthold and seconded by Rich Murphy.

\*Non-submitted ballots occur if voters fail to click on the "Submit" button, do not receive their ballot because of internet issues, or opt not to vote. According to ElectionBuddy, the ballot completion rates in this election were substantially higher than usual for this type of election.

#### **Election Ballot Examination**

On June 24th, the Election Committee emailed interested parties and candidates the procedures for ballot inspection which were also posted on the MWC Election website. These procedures were in compliance with social-distancing guidelines during the COVID-19 pandemic in the region.

Per ARTICLE VIII, Section 6 of the MWC Constitution, the Election Committee has preserved the ballots from the June 15 election and is making them available for examination by any delegate or officer of an affiliated organization until December 15, 2020.

Five requests to inspect ballots were received by the Election Committee; 2 delegates subsequently set up appointments and inspected ballots on July 1st and July 8th at the IATSE Local 22 Hall.

#### **Election Challenge**

On July 6th, candidate Bunn submitted an information request to the Election Committee to which the Committee replied on July 13th. On July 13th, candidate Bunn filed an election challenge which is being reviewed by the Election Committee.

#### **Evening with Labor**

George Farenthold, Chair

As previously reported, we rescheduled this year's EWL to October 16 due to the COVID-19 shutdowns. We've maintained contact with Martin's, which as of last Friday reported that they're still trying to work out plans that will be in accordance to Prince George's County Guidelines for reopening. Currently, they are limited to no more than 100 people per room.

While things may change by October, given the health risks to our attendees – there will certainly not be a vaccine by then -- we have to seriously consider rescheduling to March 2021 at this point. If we do decide to reschedule to next year, Martin's will forward our entire deposit to the new date with 2021 pricing.

#### **COVID-19 RESPONSE**

The bulk of the funding provided by the Greater Washington Community Foundation and the United Way National Capital Area grants ended on June 15<sup>th</sup>. Approximately 88% of the total funding is spent. As of

July 16, 588 workers received food, rent/mortgage and utility assistance. A total of 720 unique services were provided as some workers received food cards in addition to help with late bills. Seventyseven percent (77%) addressed food insecurity, 11% utilities (electric, gas, water), 8% went to rent and mortgage and the remaining 4% provided assistance for medical and auto payments.

Members in the following locals were served: AFSCME 709, 1959 & 1207, IBT 639 & 922, Pile Drivers Local 441, SEIU 32BJ, UNITE HERE 23 & 25.

#### **CSA DOUBLES DOWN ON HELPING WORKERS**

Frank Gaskins life has now been touched twice by the Community Services Agency. The first time was when he participated in CSA's signature Building Futures Construction Pre-Apprenticeship program. He graduated and went on to become an apprentice with Pile Drivers Local 441 (part of the Carpenters), working as a pile driver. The second time was when CSA's Emergency Assistance Fund helped him during a brief layoff due to COVID-19 earlier this year. "The Emergency Assistance that helped to pay my Pepco bill really helped alleviate that temporary financial stress," said Gaskins. "Frank's story is a great example of how the local labor movement enables CSA to advance its mission to help workers, support labor and strengthen communities," said CSA Executive Director Sonte DuCote. "We are grateful to every local that's made contributions in recent months, as well as the Greater Washington Community Foundation and the United Way National Capital Area, for helping to make critical COVID-19 assistance available to area workers." #### **BUILDING FUTURES PRE-APPRENTICESHIP PROGRAM**

July update: The agency's Building Futures Pre-apprenticeship Program launched its virtual classroom successfully on June 15. The hands-on portion of the program will take place at the DC OPCM Local

891 following CDC and District of Columbia COVID-19 guidelines, and is tabled for July.

(June report) During the past month, CSA's Client Services Coordinator, Sylvia Casaro-Dietert and her team completed virtual recruitment activities in preparation for the Building Futures Construction Pre-Apprenticeship Program summer cohorts. Building Futures Virtual Classroom will be launched on June 15 as a hybrid model to be complemented with in-person training later in July or when gatherings of more than 10 individuals becomes available in DC, which is where the training site is located.

Building Futures program activities and outcomes were as follows:

 Screening and enrollment of 50 DC residents to participate in the upcoming summer cohorts funded by UPO CSBG and DOES respectively. Activities: Weekly virtual recruitment events for government and community partners, daily processing

of candidates' intakes and engagement activities to ensure process quality and candidate retention.

- Adaptation of AFL-CIO-approved MC3 Curriculum and BF Applications for distance learning.
   Activities: Content formatting, creation/ compilation of self-learning projects and daily student assignments by module.
- Google Classroom and Zoom. Activities: Research, identification and set-up of low-cost, accessible and reliable digital platforms for Building Futures Virtual Classroom.
- Ready-to-go Instructors. Activities: Coordination of BF Instructors' regarding online instruction and schedule.



- Client engagement and retention. Activities: Follow-up and support of active and newly hired graduates.
- Accountability. Activities: Preparation and submissions of monthly/ quarterly reports; regular check-ins with contracts and grant officers to stay updated and maintain open lines of communication during the pandemic.
- Marketing of Union Registered
  Apprenticeship. Activities: Regular check-ins
  with the building and construction trades union
  and their joint apprenticeship training
  committees to promote BF pre-apprenticeship,
  identify trade opportunities for women, veterans
  and minority graduates from our program, and
  include them as guest speakers to present their
  trade and registered apprenticeship programs in
  BF Virtual Classroom.



#### **CLAIMANT ADVOCACY PROGRAM**

Tonya Love, Program Director; Lolita Martin, Attorney

Overall objective: Advised and represented claimants before the Office of Administrative Hearings. Discussed existing issues with DOES regarding regular UI, PUA, PUEC and FPUC. Finally, the most recent objective was/is to protect and preserve the existing language that provides CAP funding under current the terms and conditions set forth in the requisite provision of the Act.

- 1. Invoiced for the month of May in the amount of \$50,625.00. Invoiced for the month of June in the amount of \$72,187.50.
- 2. Assisted hundreds of union and non-union members in accessing the UI system in DC, with multiple emails, calls and texts to POCs at DOES.
- 3. Took part in multiple conference calls with legal service providers and CM Silverman's staff regarding a proposed amendment intended to be included in the BSA and one that would have modified the existing CAP legislation. MWC, inclusive of the Program Dir. of CAP met with the CM's staff in order to gain a full understanding of the intent and effect of the proposed amendment. Following the meeting, all provisions that MWC perceived as having a negative impact on CAP were removed. Furthermore, over the course of subsequent conversations with Silverman's office, this amendment was further revised, still leaving intact CAP's funding and shifting focus to DOES modernization initiatives. CM Silverman and legal service providers will continue to work together to try to resolve issues that became blatantly apparent following the increased number of unemployment claims as a result of COVID19.
- 4. Began and will continue discussions with DOES regarding COVID19 and how the transition to fully reopening DC could impact employees (currently claiming UI) that are concerned about returning to work.
- 5. Monthly DOES conference call with recommendations for procedural changes and expediting decisions/payment of benefits.

#### **UNION CITIES**

Chris Garlock, Coordinator

July update: The June 15 MWC election and follow-up was a main focus of work last month, as was the Heroes Caravan and support for unions supporting the BLM actions. Also, the weekly LaborFest screenings, which began in April and were planned to move to monthly, returned to a weekly schedule last week due to the new availability of a number of free labor films.

(June report) As I have since the beginning of the COVID-19 emergency shutdown three months



ago on March 13, I have continued to work closely with Acting President Washington and the MWC staff to coordinate the remote operation of the Metro Washington Council and ensure continuity of the Metro Council's ability to carry out our responsibilities to our affiliates and the local labor movement.



In addition to my usual day-to-day duties, a major focus of my work over the last month has been supporting the Election
Committee's work preparing for the June 15 election of a new president and two board members. That has involved numerous meetings with the committee as well as with the staff of both ElectionBuddy and LaborKey. It's also involved extensive and detailed efforts to conduct outreach to MWC affiliates, leaders and delegates to update their information and membership. With nearly 200 affiliated locals and over

400 delegates, this has been a massive undertaking under obviously unusual circumstances.

Another major component of my work continues to be maintenance and support for the MWC professional Zoom account, facilitating remote meetings for MWC staff, the Board, Election Committee, the LaborFest virtual screenings and COPE Town Halls.

Several mobilization efforts were undertaken over the last month, one around the Workers First Caravan, originally scheduled for June 3 and now set for this Wednesday, June 17, the other around helping coordinate labor response/involvement with the ongoing Black Lives Matters protests. Work on both continues.

Here are highlights of my other work:

#### Union City, Union City Radio, MWC social media

Produced, published and distributed latest local labor news on the MWC's Union City daily, Union City Radio (WPFW 89.3FM) and Facebook/Twitter feeds, including extensive coverage of the COVID-19 pandemic and the efforts of DC-area unions and workers.

Union City has continued to appear every weekday since March 16; Union City Radio (WPFW 89.3FM) continues to run 7 days a week (formerly was on weekdays only); Your Rights At Work has broadcast every Thursday as usual.

I have continued working with all MWC staff to keep the labor community informed about news and resources on the local response to the pandemic, including keeping our website and social media – including <a href="Twitter">Twitter</a> and <a href="Facebook">Facebook</a> -- up-to-date, with the <a href="website">website</a> – including the COPE, <a href="CAP">CAP</a> and <a href="CSA">CSA</a> pages – updated as necessary.

**MWC** meetings: Coordinated with AP Washington and the Board to hold the May Board meeting on May 18 and the delegate meeting on May 19, including preparing reports, notifying affiliates/delegates, etc. Both meetings were well-attended and the tech issues from previous meetings were resolved.

MWC check log-in: Opened, sorted, logged in MWC mail and checks.

**Database updates:** Updated MWC and LaborKey databases as necessary.
