Metropolitan Washington Council Executive Board Meeting MINUTES July 20, 2020 (Via Zoom), 3-5pm

Call to Order & Welcome: MWC president Dyana Forester called the meeting to order and asked for a moment of silence for Rep. John Lewis.

Minutes: May 18 minutes unanimously approved.

President's Report: Dyana Forester reviewed her written report, submitted in the July 20 Board packet. Highlights include: Administration, Management, Financial Management, Affiliate Support and Looking ahead...Priorities for July to September.

Financial Report: The May reports were approved as reported after review/discussion. **Evening with Labor Report:** Following a discussion of Committee chair George Farenthold's report, the Board voted to approve a move of EWL to 2021, March 6, 13 or 20, otherwise early April. The possibility of a virtual awards event was also discussed; it was agreed that further investigation was warranted and that safety of attendees must be the paramount concern. **Election Committee Report:** Committee chair David Fernandez-Barrial reviewed the committee's written report and received kudos from a number of Board members on accomplishing the election "under challenging circumstances."

Organizational Reports

MWC staff – David Stephen (COPE), Tonya Love (CAP) and Chris Garlock (UnIon Cities) -reviewed their written reports (see last month's Board packet), including an extended discussion on the upcoming Fall political season and COPE activities.

Affiliate Updates

Andrew Washington (AFSCME Council 20) reported on his recent meeting with DC City Council Chair Mendelson regarding the Budget Support Act; discussion ensued.

Stephen Frum (NNU) reported on the New Hospital at Saint Elizabeth Act of 2020, and efforts to generate support for amendments for a labor peace agreement or neutrality "or anything that just holds UHS accountable to what they've said publicly." He also noted NNU's plan for a demonstration at the U.S. Capitol for the HEROES Act.


COVID-19 / EMERGENCY ASSISTANCE

BUILDING FUTURES CONSTRUCTION PRE-APPRENTICESHIP PROGRAM

BUILDING FUTURES Pre-apprenticeship Program graduated 22 DC residents from its UPO-funded virtual program. More than 50% are already placed in good paying jobs and apprenticeships. Apprenticeship sponsors this month included Heat and Frost Insulators Local 24, Piledrivers, Heavy Equipment Operators Local 77, Sheet Metal Workers Local 100, and Plumbers Local 5.

A new DOES-funded cohort started last week with a total of 14 DC residents participating in BUILDING FUTURES virtual classroom. Students in this class are veterans and older youth 19-24 yearsof-age with an interest in the building and construction trades.

As part of the program, students receive OSHA 10, Flagger Safety Training, CPR, First Aid and AED, and Scaffold

User Training. In addition, they receive job counseling and individualized case management and referrals to other programs in the city to address any challenges to employment.

CLAIMANT ADVOCACY PROGRAM

Tonya Love, Program Director; Lolita Martin, Attorney

The Claimant Advocacy Program's overall objective is to advise and represent claimants with DC unemployment benefits who have a scheduled hearing before the Office of Administrative Hearings.

Additional tasks:

- Discussed existing issues with DOES regarding regular UI, PUA, PUEC and FPUC.
- Check-ins with other stakeholders on issues on a broader level that affect unemployment benefits.
- Suggest and connect UI claimants with other resources, when/if needed.

Summary:

- 1. Invoiced for the month of June in the amount of \$72,187.50. Invoiced for the July in the amount of \$67,375.00. Invoiced for August in the amount of \$49,500.00. CAP has more than tripled the number of cases over the period of the pandemic.
- CAP continues to assist hundreds of union and non-union members in accessing the UI system in DC, with multiple emails, calls and texts to POCs at DOES. We have assisted, escalated and resolved at least 20-30 union members' claims during the months of July and August, which are unbilled hours. As for billed hours in July: (3) 32BJ; (2) SEIU 722; (1) WTU 6, (1) UNITE HERE 25 members represented. In August: (2) SEIU 722; (1) 32BJ members were represented. Overall, less than 10% of our billable cases have involved affiliated union members.
- 3. Began and will continue discussions with DOES regarding COVID19 and how the transition to fully reopening DC could impact employees (currently claiming UI) that are concerned about returning to work.
- 4. Continued discussions with DOES to reduce the misinformation regarding Pandemic Unemployment Assistance (PUA) applications as well as the PUA process and backlog.
- 5. Monthly DOES conference call with recommendations for procedural changes and expediting decisions/payment of benefits.
- 6. Bi-weekly conference calls with the Commission Task Force of the DC Office of Administrative Hearings.

ELECTION COMMITTEE REPORT

David Fernandez-Barrial, Chair Members: Chuck Clay, Amy Millar, Kathleen Moors, Gina Walton

On July 15, Eric Bunn Sr. submitted a protest of the 2020 election for president of the Metro Washington Council. The appeal (see attached) alleges violations of multiple articles of the Council's constitution in the conduct of the election and urges that it be re-run.

Upon careful review, we find the allegations to be without merit and recommend that the Board reject the appeal.

While we respond to some of the specific allegations below, in general they are either inaccurate or appear to be based on a foregone conclusion. We would like to point out that Mr. Bunn chose not to avail himself of the opportunity to inspect the election ballots before filing his appeal.

The 2020 MWC election, despite being conducted under extraordinary circumstances – the first contested election for president in the midst of a historic global pandemic – drew record participation by affiliates and delegates and had a voter response rate well above average for online elections. The election committee and MWC staff worked diligently to ensure maximum participation by affiliates, to provide a fair election and to do so with the utmost transparency, which we feel has been affirmed by the subsequent overall positive response by affiliates, delegates and the Executive Board.

Below are the MWC Election Committee's responses to specific points raised in Mr. Bunn's appeal:

Credentials Committee

Establishment of the Credentials Committee is – per Article XV, Section 1 of the MWC Constitution – the purview of the President and it is not known when the last one was appointed. (For the record, other constitutionally-required committees that also do not exist are: Ethics, Affiliations, Mobilization, Organizing, Economic Development, Relief Appeals, Civil Rights and Constitution/By-Laws.)

There was ample opportunity for delegates or candidates to suggest or request the appointment of a Credentials Committee.

Lastly, the Election Committee was also concerned that re-credentialing all delegates and officers in advance of the special election would result in further delays to the election during the COVID-19 pandemic and was in fact violating the precedent established in previous MWC elections. Based on conversations we had with the national AFL-CIO, the committee did not want to further postpone or delay the election, because we understood that the work of labor councils around the country needed to continue.

Delegate eligibility

The Committee followed the identical delegate eligibility procedure as in previous MWC elections; affiliates were notified multiple times of the need to check and update their delegates, and updated lists of delegates were posted on the election page on the MWC website. These updates occurred in advance of the originally-scheduled March election date, prior to the pandemic closures. In fact, due to the delay due to the COVID-19 pandemic, affiliates were afforded ample additional time to update their delegates.

Affiliates were clearly notified in advance of the deadlines for updates, as well as that the final list of updated delegates would be used to determine eligibility to vote. Those who were on the list and who responded to the June 15 roll call comprised the final voter list provided to ElectionBuddy, and their local's votes were apportioned to those delegates from each local.

Distribution of affiliate votes

ElectionBuddy (not Zoom) was the platform used for the actual election voting, and affiliate voting strength was distributed among the delegates present from each local, per the provisions of the MWC Constitution at Article IV, Section 3.

Variance between registered delegates and those who voted

As indicated at the outset in the election meeting, delegates registered in the roll call received ballots, even those few who dropped out of the Zoom room; this possibility was the reason the Election Committee and staff worked hard to ensure that we had email and/or cell phone numbers for delegates, so that they would be sure to receive ballots, irrespective of possible technical issues that a delegate might encounter.

Regarding the difference between the number of delegates registered and the number of votes in the election for president, there are three possible reasons for this: 1) some delegates neglected to click on the "confirm" button; 2) some delegates – despite the best efforts by the committee, staff and ElectionBuddy – had unresolvable technical issues; 3) some delegates opted not to vote in the election for president or to leave the meeting prior to, or during, the voting.

As reported in the Election Committee report presented at the July 20th MWC delegates meeting, during the June 15th Election, the vote for the President position, 185 ballots were submitted of 208 eligible voters - that is, 89% participation, which is a record turnout for a MWC election.

Ballot inspection

Regarding the concerns raised about inspecting the ballots, Mr Bunn has been afforded the same opportunity to inspect the ballots as everyone else; it has been his choice not to do so. Other delegates have inspected the ballots and found the process fair and acceptable.

Availability of records for review

All candidates were notified of the availability of the records for review as outlined in Article VIII, Section 3 in an email sent to them on June 24, 2020. The same email was sent to the five delegates who requested the opportunity to inspect the ballots.

Also, the election committee followed the same process for candidate mailings to delegates as in previous elections, providing equal access for all candidates and protecting delegate privacy.

List of MWC affiliates

Regarding the list of MWC affiliates, it has long been the practice of the MWC to publish a Directory of Affiliates – which now exists in both a hard-copy version (updated annually) and an online version (updated on an ongoing basis). This was discussed and approved by the Executive Board prior to the release of the first Directory.

For the reasons outlined above, the Election Committee asserts that Mr. Bunn's protest of the results of the June 15, 2020 MWC Election is without merit.
