President's Report

Financial

- notified organizational structure needed to be in place to maintain funding
- legislation Clean Hands has to do with receiving money from DC government; labor organizations were not considered when this legislation was enacted
 - a. has clean hands certificate
 - b. 501 (c)(5) lost tax-exempt status in 2018, has since gotten it back
 - c. need to submit business license; need to retain legal counsel to help through this process and has received two proposals for this purpose
- wants to have a special board meeting within the next two weeks to go over all
 things that impact the budget and to address the finances in depth, which will
 include vacation balances and health insurance discussions; employees with
 high balances have started taking leave where feasible
- all things financial will impact business license; wants to review finances from an organizational structure standpoint
- everything needs to be taken care of by 3/1/2021

Legislative

- count every vote action/rally
- types of legislation Protect Workers Workers Compensation; Mendelsohn pulled emergency legislation to re-open DC schools off the agenda
- working with David to assess where legislation is currently, also to put forth a plan for online mobilization; how to lobby virtually

- only one individual challenged the election
- as a Board, that is split on this issue, need to come to some level of consensus
 of where we want to move with this matter
- the candidate wished to move this matter to the AFL-CIO for a decision but cannot ignore constitutional obligation and need to make some type of decision; boards duty to act prior to it being moved to the AFL-CIO
- same conversation today as 30 days ago
- volunteers for election appeals committee Donna Brockington, Stephen Frum,
 Liz Davis, Michael Spiller, Robin Burns, Ann Hoffman

 per the constitution, there can be only one agenda item per special meeting so Chuck Clay suggested to discuss appeals matter in a special meeting immediately following the finance discussion special meeting; President Forester accepted this suggestion

Evening with Labor: presented by George Farenthold

- fiduciary responsibility about \$160,000 in bank and need to give fair value for the money

- will schedule a fundraiser committee meeting to figure out having this event virtually
- no cancellation limit at Martin's Crossing at the moment
- Prince Georges County restrictions on meeting size
- want to recognize the awardees and need a day to celebrate but must be safe in doing so
- Liz Davis wants to be added to the fundraiser committee

Election Committee Report: presented by Gina Walton

- there were four candidates for the open board seat, but Myra Hines (DCMA) and Laura (WTU Sticks) were determined to be ineligible because there is already representation on the board form their areas
- Tom Killeen (SMART) and Theresa Dudley (PGCEA) were determined to be eligible
- Tom Killeen is the only candidate for the open Executive Board position as
 Theresa Dudley did not return acceptance for in time per the instructions
- Motion to accept Tom Killeen by acclamation will be made at the delegates meeting on 11/17/2020

- there is another vacant seat as Jim Griffin resigned from his board seat October 30th; nominations will be open at the 11/17/2020 delegates meeting and elections will be held at the 12/22/2020 meeting
- Discussion on election protocol Wanda Shelton-Martin– Article 8, Section 5, subsections (a) and (b) states that the person needs 50% + 1 and if all candidates do not achieve that, is there a runoff; Gina Walton will look into this matter and answer accordingly.
