UNION Cities: *Chris Garlock* - Dancers at Washington Bal-

let: Eleni Kallas, AGMA-DC thanked President Williams, CSA's Kathleen McKirchy and Union Cities Coordinator Chris Garlock for all their help in the ongoing struggle for a contract by 20 lockedout dancers. She introduced several of the dancers: Rungiao Du, Erin Mahoney Du, Chip Coleman, who addressed the Council. "Our spirits were waning but they were brought back up on the picket-line in the rain and cold last December," said dancer Erin Mahoney Du. Du and fellow locked-out Washington Ballet dancers Rungiao Du and Chip Coleman reported that the 20 dancers are holding strong despite the financial hardships created by the 3-month lockout. The dancers have been out of work since December, when management cancelled The Nutcracker in the midst of contract negotiations. "We saw so many faces we'd never seen before on that line," said Rungiao Du. "We were totally shocked to see so much support from so many."

Murphy reported that the Committee had determined that all candidates on the slate for Council officers are eligible to hold office, and that have all agreed to hold office if elected. Murphy recommended that the Council Secretary move for a vote on the entire slate and it was moved, seconded and approved. The Council officers were then sworn in by MD State/DC AFL-CIO President Fred Mason. President Williams thanked the delegates for their vote of confidence and pledged to work hard "to continue to build the best local labor movement possible over the course of the next three vears."

Tommy Ratliff reported on ongoing contract negotiations with Waste Management. Strike next month by 60 area workers is possible.

- Garlock reported that contract negotiations continue at NPR, PBS and WJLA by NABET 31; passed out new Council brochure; two upcoming films deal with labor issues: 3/3 "A Union Man: The Life and Work of Julius Margolin" at CWA; 3/15 "Meeting Face to Face: Iraqui Labor Leaders Tour the U.S." at AFL-CIO.; new DC Student Labor Project Coordinator Ashwini Jaising reported on status of the Living Wage campaign at Georgetown (rally tomorrow).

Reports Of Local Unions

- Mailers 29: Washington Post declared impasse on January 27 and implemented section taking pension away from utility workers, instead putting half into a "raise" and half into the Post's 401K. Urged delegates to go to washingtonpostunfair.com and sign petition.

Constituency Groups

- A. Philip Randolph Institute DC (APRI): Wanda Shelton-Martin reminded delegates that the annual birthday celebration is April 15.

COPE

Craig Simpson reported on the 2006 interview/endorsement process. MD State/DC AFL-CIO President Fred Mason reported on the impact of Change To Win disaffiliations of about 33 local unions; "as of today, 27 of them have re-affiliated under the Solidarity Charter program." Mason also reported that "Today the national AFL-CIO announced an agreement with the NEA to allow locals to directly affiliate with the AFL-CIO." Mason also updated delegates on the upcoming MD State/DC AFL-CIO meeting on 2/28 to make endorsements for US Senate and Maryland Governor and reviewed the process.

President Williams took note of RNs Working Together, a new coalition of nurses organizing/working together on the national level.

Community Services Agency

President Williams, on behalf of CSA Executive Director Kathleen Mckirchy, reported:

Building Trades Recruitment Grant: to DC residents for construction jobs. Plan to go out in community and find people to refer to apprenticeship programs or pre-apprenticeship programs. Please help spread the word. Not just limited to stadium construction jobs; lots of other building projects in DC in next 10 years.

Hospitality Training Program: graduated 18 people today in immersion program from Shaw neighborhood; 2-week program. Now need to get them into OJT training and then jobs.

Fred Allen reported on the upcoming Evening With Labor.
