

Executive Board Meeting Minutes

Metropolitan Washington Council, AFL-CIO

President Williams called the meeting to order at 4:06p.

Special Order of Business:

DC Polling Report: Ron Lester & Assoc

Pollster Ron Lester reviewed his Metro Council poll findings in detail; concluding that "if the Mayor had a strong candidate opposing him, he could be defeated this year." Questions/discussion ensued. Lester recommended doing "opposition research"; 41% Fenty unfavorables are up for grabs. Discussed planned poll in Prince George's County.

DC: Alya Mbamba reported on pending bills including: Housing and Economic Development Labor Standards Bill; DC Attorney General Elected Term Amendment Legislation; Grievance Filing Bill; Secure Communities Program; DC COPE Chair Fred Allen reported on the DC COPE Committee review of the OPC Nomination of Vicki Beasley. The Committee recommends that the Council not support her nomination. Moved and seconded to oppose the nomination;

unanimously approved. MD: Rick Powell reported that Secretary the Council will again be convening weekly meetings in Annapolis starting Monday February 1 through the entire session; these are work sessions for those who have bills before the legislature; was very effective last year; also reported on recent meeting with Mike Miller and President Williams to clear the air/ turn over a new leaf; 6 labor bills coming up; upcoming Tri-County COPE meeting— Mike Miller to speak.

President Williams recommended meeting the second week in February (instead of 4th Monday) to deal with pressing matters, including the Council's 2010 workplan, budget and per cap increase. Tuesday 2/9 from 12-3P was tentatively set; will confirm via calls/email.
