May Delegate meeting called to order 6:38p by President Williams

Delegate Eartha Issac, AFGE 2978 was sworn in.

Guest: President Williams suspended the regular order of business to welcome Congresswoman Donna Edwards, who he called "A labor Delegate with a real passion for working men and women. She doesn't just vote for us but is an active advocate." Edwards, after a standing ovation, thanked President Williams and the delegates, saying that coming to the AFL-CIO headquarters and the Metro Council "is very comfortable for me; this is my second home." She described how she was grilled on a number of labor issues during a recent meeting with the editorial board of The Washington Post, and took the opportunity to strongly defend unions and worker's rights to organize. "It reminded me of why workers need representatives who don't just cast the right vote but who will be fighters for you as well." She reported that she's been speaking our strongly in support of government workers, "who are being beaten up every day over wages, benefits and rights. We need government workers to help get us off the ground in this economic crisis; the American workers cannot afford another two decades like the last two. We have nothing left to give; we're at rock bottom." Edwards added that "my backbone is you and all the workers you represent and with that backbone there's nothing we can't do." After taking questions from delegates, Edwards posed for a group photo with the Union Summer interns and invited everyone to attend her upcoming birthday party.
