Metropolitan Washington Council, AFL-CIO

July 19, 2010

Meeting called to order at 7:45pm by President Joslyn Williams.

This was a special meeting called for the sole purpose of making decisions about political endorsements in state and local races within the jurisdiction of the Metro Washington Council, AFL-CIO.

NO POSITION means the MWC AFL-CIO takes no position in a race, leaving locals free to make their own decisions about candidates

NO ENDORSEMENT means the MWC AFL-CIO opposes a candidate's endorsement and encourages locals to refrain from making any endorsement of that candidate.

NO RECOMMENDATION means the MWC AFL-CIO has nothing to say about a given race.

ENDORSEMENT of a candidate(s) requires a 2/3 majority.

To be considered for endorsement, candidates must have returned a completed questionnaire by the publicized deadline.

A recommendation from Tri-County COPE was inadvertently left off the list of candidates for consideration by the Executive Board. It was moved, seconded and adopted to endorse Cliff Savoy, mem-

ber of Sheet Metal Local 100, for the Calvert County Democratic Central Committee and the Calvert County School Board. It was moved, seconded and approved to send a letter to At-Large DC City Councilmember Kwame Brown, expressing our concern and dismay at his harsh treatment of labor representatives at the hearing on the Economic Stimulus bill held at the end of June.

President Williams announced that he was not prepared to make a report on the proposal for the running of an independent campaign in the race for Mayor of the District of Columbia. He will discuss this proposal with the Executive Board as soon as possible. He also encouraged all locals to plan on attending Labor’s reception for endorsed Mayoral Candidate Vincent Gray on July 27, from 5P-7P at IBEW, 900 7th Street NW. Maximum contribution is \$2000, checks to be made payable to Vincent Gray for Mayor.

There being no further business the meeting adjourned at 9:30pm.
